1. Financial Management at the Advanced Stage

This exam can be a suitable fit for you if you have professional experience in financial management or career aspirations in this field.

The goal of Advanced Financial Management (AFM) is to help you develop the necessary information, abilities, and professional judgment so that you can make recommendations or decisions regarding the financial management of a company.

Financial management (FM) serves as its key support. We've discovered that having solid FM knowledge increases your chances of passing the AFM.
